# 11.0 **QUALIFYING REQUIREMENTS:**

A The bidder should be a manufacturer (OR) authorised Dealer / Distributor of rough terrain hydraulic mobile cranes of capacity 30T or above and should have supplied and commissioned at least one "Rough terrain hydraulic mobile Crane" of capacity 30T or above during last 7 years ending last day of the month previous to the date of techno-

commercial bid opening. Dealer / Distributor should be specially authorised by the manufacturer for participating in the bid. The average annual turnover of the bidder in the preceding three (03) financial years as В on the date of techno-commercial bid opening, shall not be less than Rs. 124.89 Lakhs (Rupees One Hundred Twenty Four Lakhs & Eighty Nine Thousand). Notes: (i) Other income shall not be considered for arriving at annual turnover. (ii) In case where audited results for the last financial year as on the date of technocommercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, the bidder is not able to submit certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
