## **BRIEF SCOPE OF WORK:**

The scope of the subject package envisages "Annual Maintenance Contract for Ash slurry disposal lines and Ash pond management of NTECL".

## **QUALIFYING REQUIREMENTS (OR):**

A. The average annual turnover of the bidder in the preceding three (03) financial years as on the date of techno-commercial bid opening, shall not be less than Rs.78.64 Lakhs (Rupees seventy eight lakhs and sixty four thousand).

## Notes:

- i) Other income shall not be considered for arriving at annual turnover.
- ii) In case where audited results for the last financial year as on the date of technocommercial bid opening are not available, the financial results certified by a practicing Chartered Accountants shall be considered acceptable. In case, the bidder is not able to submit the certificate from Practicing Chartered Accountants certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountants certifying the financial parameters is not available.

i) Single (01) order value not less than Rs.62.91 Lakhs. (Rupees sixty two lakhs and ninety one thousand)

ii) Two (02) orders each of value not less than Rs.39.32 Lakhs (Rupees thirty nine lakhs and thirty two thousand)

#### OR

iii) Three (03) orders each of value not less than Rs.31.46 lakhs (Rupees thirty one lakhs and forty six thousand)

\*Execution of following jobs in isolation shall not be treated as credential for the subject works:

- i. Execution of structural fabrication only
- ii. Civil pedestal jobs for laying of ash pipe lines only
- iii. Pipe line rotation job only
- C The bidder should have Provident Fund code (PF code) number allotted by concerned Regional Provident Fund Authority.
- D | The bidder should have GSTIN number issued by concerned authorities.

<u>Note</u>:- The work "executed" means that the bidder should have achieved the progress specified in the QR even if the total contract is not completed / closed. The same shall be supported by documentary evidence issued by concerned authority.
